Thereafter, the accounts of the Federation for the years 2016 to 2018 were presented which were unanimously passed by the house.

The General Secretary apprised the house about ongoing negotiations for 11th Bi-Partite Settlement in detail.

He apprised the members about the other burning issues of immediate concern to bank employees more particularly the employees of Punjab National Bank. He said that our organization NCBE being an independent, non-political and 2nd largest workmen trade union of Indian Banking Industry always remained instrumental in achieving respectable Bi-Partite Settlements and also in maneuvering the trade union movement of bank employees from the political clutches.

The General Secretary in his address showed his serious concern over the growing NPAs of the Bank. He advised the members to help the management of the Bank in all possible ways as and when required by them while taking steps for recovery of the NPAs from the defaulters.

The Central Committee discussed at length various issues of immediate concern to bank employees. A long and lively discussion took place on all the issues.
