TO ALL MEMBERS

Dear comrades,

We have already informed you vide our Circular No.14/2010 dated 28-04-2010 that on 27th April 2010 NCBE and other unions have signed 9th Bi-partite Settlement on wage revision and Settlement on 2nd option for pension. With the conclusion of Bipartite Settlement and Settlement on 2nd option for pension the anxiety, frustration and waiting of lacs of bank employees all over the country is over. While patience pays, determination definitely derives dividends. It has become true in the case of bank employees and officers.

The role of NCBE is most significant, NCBE has to do an extremely difficult task of tight rope walking and achieve things. During the entire period of agitation, NCBE stood like a rock and brought the Trophy home

Comrades, NCBE has done its best for achieving reasonable and justified wage revision. Let us contribute whole heartedly to strengthen NCBE. This is an occasion on which Federation and its affiliated unions also expect to build up their funds. It is, therefore, decided in consultation with President and Secretary of the Federation that levy should be collected @ 2% of net arrears paid by the bank (before deduction of income tax) subject to a maximum of Rs.2,000/- from clerks and Rs.1,000/- from the members of sub staff.

All the General Secretaries/Deputy General Secretaries of affiliated unions are advised to issue necessary instructions to the branches/units to collect levy from all our members and to remit the amount so collected by draft favouring "All India PNB Staff Federation", payable at Delhi to the Central Office of the Federation. Out of the amount of levy so received, the dues payable to NCBE will be cleared first. After remitting the dues payable to NCBE, half of the remaining balance amount will be retained by the Federation and rest of the amount will be remitted to the affiliated unions. Out of share of affiliated unions in the states of U.P., Bihar and Uttrakhand; one-half of the amount will be remitted to the Deputy General Secretaries of the Circles and other-half will be remitted to the General Secretary.

We convey our deepest sense of thanks to all the leaders of affiliated unions and the members for having exhibited solidarity and patience during the protracted negotiations and congratulate them on achieving 9th Bi-partite Settlement. We are sure that the 9th Bi-partite Settlement will be cherished by the members for a long time to come. On this occasion, we call upon our members to rededicate themselves to serve the customers so as to protect the interest of Indian Banking System from falling into the clutches of International Institutions.

We once again salute each and every member for the faith reposed to the organisation.

Reg.:- Levy of 9th Bi-partite Settlement

Vide HRD Division Circular No. 629 Dated 12-06-2010, it has been decided by the Bank that the facility of deduction of union's levy from the arrears of 9th Bi-partite Settlement be provided to all the Unions who are being given the check-off facility, on receipt of request from them.

In this regard, you are requested to deduct the levy from the members of our union @ 2% of the net arrears paid by the Bank (before deduction of income tax) subject to a maximum of Rs.2,000/- for clerks and Rs.1,000/- for the members of sub-staff from the arrears of 9th Bi-partite Settlement and remit the same through draft payable at Delhi favouring All India PNB Staff Federation to the Central Office of the Federation i.e. R-8/38, Raj Nagar, Ghaziabad (U.P.).
