NATIONAL EXECUTIVE COMMITTEE MEETING

A Meeting of the National Executive Committee, under the Presidentship Com. Vinil Saxena, President of our organisation, was held on the 7th March 2018 at Mumbai.

2. At the request of Com.Sanjeev Bandlish, General Secretary, the House observed Two minutes' silence in memory of Com. P. Lakshmi Narasaiah, former General Secretary of NCBE and doyen of the Bank's trade union movement in the country, who breathed his last on the 9th February 2018 after brief illness.

3. Com. Sanjeev Bandlish apprised the house about the latest developments with regard to wage revision. Com. Bandlish informed that IBA had postponed the meeting scheduled for 21st February 2018 in view of the disturbed situation in the banking sector on account of the recent PNB fraud and said that the meeting may be held within a month.

4. On the agitational programme of UFBU, Com. Bandlish said that the representatives of UFBU met on 23rd February 2018 at Chennai and considering the vitiated atmosphere in the entire banking sector in the aftermath of PNB fraud decided not to proceed with the proposed strike on 15th March 2018. He also informed about the decisions of UFBU in the said meeting to organise Press Meet in all State Capitals and to hold Dharna before Parliament at New Delhi on 21st March 2018.

5. Com. Bandlish informed the house that Com.Vinil Saxena, President has retired from Bank's service on superannuation in the month of December 2017 and submitted his resignation to the post of President and requested the house to decide on the same. Subsequent to acceptance of resignation submitted by Com. Vinil Saxena, the House unanimously co-opted **Com. S. C. Balaji of All Indian Overseas Bank Employees Federation to the position of President of NCBE.**

6. Later, in the interim vacancies that have arisen since the last Meeting, the under-noted co-options to the National Executive and Central Committee positions mentioned thereagainst their names were proposed by the General Secretary and were unanimously approved by the House:


