**1. Meeting with Officials of Finance Ministry :-**

We have received letters from AIBOA, INBOC & NOBW that all the 9 unions should meet the Government. Since Government did not accept it, this meeting has not been arranged.

**2. General Strike on 28.2.2012 :-**

In the UFBU meeting held on 13.12.2011, while welcoming the common demands of the Central Trade Unions for their call for strike on 28.2.2012, it was decided that each constituent union will discuss the matter at their level by the beginning of January, 2012 & take a decision. Please let us know the decision taken by your organisation. So far AIBEA, BEFI and NOBO have informed us that they will be joining the strike.

**3. Letter received from AIBOC :-**

**4. UFBU meeting :-**

A meeting of the UFBU will be held at the earliest to discuss about the following:

- a) Review of last round of UFBU programme in Dec/Jan.

- c) Issues to be submitted to the Fin. Ministry on our wish list for Budget 2012.
- d) 28<sup>th</sup> February, 2012 Strike.
- e) Electing new convener for UFBU.
