- Procedure to be adopted for selecting Articles for providing Honorarium/Incentive in the above Sl. No. 8 (A): A committee under the chairmanship of GM (Rajbhasha) is to be constituted at the level of Head Office OL Department. Deputy/Assistant General Manager of HRD/PAD, AGM/Chief Manager of CCD and AGM/Chief Manager of OL Department will attend the meeting as members and member secretary respectively. The committee can convene one or more meetings in financial year. The committee will select the articles and amount of honorarium.
- Procedure to be adopted for selecting articles for providing Honorarium/Incentive in the above Sl. NO. 8 (B): A three members committee under the chairmanship of Zonal Manager/Circle Head is to be constituted. Two officials of Assistant General Manager/ Chief Manger level will be its member and OL Officer of the Zone/Circle will work as its convener. The committee can convene one or more meetings in financial year. The committee will select the articles and amount of honorarium.
- Procedure to be adopted for selecting articles for providing Honorarium/Incentive in the above Sl. No. 9: The structure of the committee will be as per the above 8(a). Proposal for sanction of incentive amount for the article published in magazine, outside from the bank is to be sent to OL Department by the concerned staff member through OIC of his office. Concerned proposal should reach OL Department within 45 days from the publication of the article. Committee, by its own discretion, can extend this 45 days period in evitable circumstances.
- Procedure to be adopted for selecting books for providing Honorarium/Incentive in the above Sl. No. 10: the structure of the committee will be as per the above 8(a). The concerned staff member will submit minimum 10 copies of the book published in financial year to OL Department through his OIC by 31st May. The committee will take final decision on the selection of best book/work for incentive. In case of books/works in any mode are not found up to the mark then no incentive will be given.
- Procedure to be adopted for selecting books for providing Honorarium/ Incentive in the above Sl. No. 11: The structure of the committee will be as per the above 8(a). The concerned staff member will submit minimum 10 copies of the translated book published in financial year to OL Department through his OIC by 31st May (direct in case of retired staff). The committee will take final decision on the selection of best book/work for incentive. In case of books/works in any mode are not found up to the mark then no incentive will be given.
- Every year one regular student from MA (Hindi) in the above Sl. No. 12 will be selected. The concerned student must have Hindi as an elective subject in the degree examination, which he/she has passed for enrolment for MA (Hindi) and he/she must have scored the highest marks amongst all the students studying as regular students along with him/her. For this, name of the student will be called from head of the Hindi Department of the University.
