

"In our earlier circular we have conveyed the decision of our UFBU meeting to take all out steps to mobilise our members and make the Morcha to Parliament programme on 15th September, 2017 a big success.

Programme Details:

- (a) The Morcha/Procession will commence by 10-00 AM on 15th September, 2017 (Friday) from Ram Leela Grounds.
- (b) All our unions should inform their members and ensure that all of them assemble at the venue before time so that the procession can be formed properly and start on time.
- (c) The front Main banner will be a common banner from UFBU only.
- (d) This banner will be followed by important leaders of UFBU constituent unions.
- (e) Then there would be flags of UFBU.
- (f) Thereafter the participation in the procession will be in the order of AIBEA, AIBOC, NCBE, AIBOA, BEFI, INBEF and INBOC.
- (g) Adequate number of placards will be prepared by UFBU-Delhi and provided to the participants.
- (h) Constituent unions can bring their own placards also but the demands are to be in conformity with the demands raised by UFBU.
- (i) Slogans to be raised by the processionists are also to be confined to our demands raised by UFBU on banking sector.
- (j) Procession will culminate in a Mass Rally/meeting at Parliament Street near DFS/MoF office, Jeevan Deep bldg. and opp. to SBI.
- (k) Central Trade Union leaders and members of Parliament will be invited to address the rally.
- (l) Press meet is being arranged on 14th Sept. evening and hence all our important leaders are requested to be in Delhi by 14th noon.
- (m) Attempts are being made to meet the Hon. Prime Minister to submit our memorandum.
All are requested to take note and mobilise accordingly.
