NATIONAL EXECUTIVE COMMITTEE MEETING ON 13TH MAY 2012

Members are aware that the period of 9th Bipartite Wage Settlement expires on the 31st October 2012 and the Unions have to submit their Charter of Demands for revision of wages and allowances to the Indian Bank's Association, well in advance, to ensure early commencement of negotiations. In this background, the National Executive of the organization met on 13th May 2012 at Mumbai mainly to discuss and deliberate on the demands to be included in the Charter of Demands for the ensuing Tenth Bipartite Wage Negotiations with Indian Bank's Association.
