"You are aware that the Central Trade Unions have given the call for All India General Strike on 28.2.2012 on various very important common demands. It is notable that this is a historic call because this call has been given jointly by all the Central Trade Unions for the first time since independence of our country. This also implies the serious situation facing the trade unions today due to the policies of the Government.

Hence the strike call has become very significant. In our UFBU meeting held on 13.12.2011, while all the unions have welcomed this move, however, felt that joining the strike needs a proper decision in their respective forum.

We have now received a Notice for a meeting convened by the Central Trade Union on 23.12.2011 at 2.30 P.M. to be participated by independent trade unions / Federations to solicit the support for their strike call.

We are enclosing the Notice and request all our constituent unions to attend this meeting."


REQUEST FOR PARTICIPATING IN THE MEETING
